

BFFS 2.4 Release Training Video Script

"BFFS 2.4 Update General Release Notes"

Hi there! Today we're going to provide you with an overview of all of the upgrades made to BFFS with the 2.4 release.



We've made quite a few changes and added functionality to help FSRs, LIEs, Field Examiners, and Misuse Teams. Let's take a look!

For FSRs, first, we've updated the FSR work flow.



The first change we've made to the workflow is an added status. In certain cases, the FSR has to send the case back to the VSC or PMC for promulgation. Previously, there was no good way to track those cases.



With this release, we've added a status called "Pending VSC/PMC" in order to capture and track those cases.



Next, we've created a field on the "Promulgate 290" status page, which holds the VA retroactive payment amount. This field has two rules: First, if the amount of the retroactive payment is greater than \$25,000, then a button called "Submit for Coach Concurrence" becomes visible. Second, if the retroactive payment is less than \$25,000, then the "Finalize Award" button becomes visible.

Finally, we added a new drop down field to the work item called "Pending Bond Receipt." This drop down field has three choices: One, Bond Received. Two, Bond Receipt NA. And finally, Bond Receipt Pending.

If you select Bond Receipt Pending, the work item moves into a status called "Pending Bond Receipt," in order to control for receipt of the bond.



For LIE's, we've added functionality to push data from the FElux and Accounting Wizard to the beneficiary record. This will end the need for duplicate entry of certain pieces of information to the beneficiary record.



We've also added "Record Status" field to the beneficiary record. There are two statuses you can choose from: Pending Review and Action, and Pending final action. Let's say, for example, that the beneficiary passed away, but we're still waiting on the final accounting from the fiduciary. We know that there will be no future field exam date, but the record still needs to be active while we're waiting on that accounting.

Previously, active records with no future exam date where we were waiting on an item before the record could be closed showed up on lists for out of control cases.

Now, with this record status field, we can differentiate which cases still require action, but no future exam.

Next, we've added a requirement to the beneficiary record. When the record shows that a fiduciary is appointed, the beneficiary record is active, and there is no additional action required from the "record status" field...

Finally, we adjusted the receive date in tasks associated with an accounting work item. We changed the rules so that we can confirm the receive date in BFFS matches the date stamp date on the accounting form. This will ensure that all tasks will be timed appropriately to fall within the 14 day required completion time.



Next, we've added some additional options for health care, to include: VA and Tricare, Tricare and HMO, VA and Medicaid, and VA and Medicare.






