# "BFFS Push to Beneficiary Record"

Hi there! Today we're going to provide you with details for the FElux and the Accounting Wizard pushing information to the beneficiary record in BFFS.





With the 2.4 release, information that is input into the FElux and/or Accounting Wizard will push to the beneficiary record.



When the LIE completes a work item, BFFS will now conduct a search of corresponding fields in the beneficiary record and FElux or Accounting Wizard.






If the fields don't match, the LIE must verify what information is the correct information.

The biggest change with this release is that BFFS will no longer pull information from the work item...





...it will now pull the information from FElux and the Accounting Wizard.



So why is this important? Let's use an example. Let's say the field examiner completes his report on May 1. Then, on May 3, the hub receives notification that the beneficiary moved and the address is updated in BFFS. If the work item isn't closed until May 5, we can immediately see the discrepancy and select the correct information for the beneficiary record, ensuring better data integrity.





Also, since the weight of the information you put into the Accounting Wizard or FElux is so important, now it will push to the beneficiary and fiduciary record.



The good news is, it will save time when closing work items, since BFFS will automatically conduct a search on fields the LIEs would otherwise have to update.



This will eliminate the duplicate work of having to update information in multiple places.



So, let's look at an example. Let's say I am the LIE and I am closing a follow-up field exam.

You can see here – the address on the beneficiary record says the address is 55 Park Avenue.



But the field examiner entered the address as 55 Park Road.

I confirmed that 55 Park Avenue is the correct address and the field examiner just accidentally typed it incorrectly.

Now I choose the correct information.



Once the correct information is selected, the LIE will click this button – "I certify updating the beneficiary and fiduciary." This means that the LIE has either manually updated or used the new beneficiary record push functionality to confirm the correct information.
