All IDES Military Services Coordinators (MSCs), Disability Rating Activity Sites (DRAS) personnel and other VA personnel supporting IDES are invited to participate.

The following call notes summarize, expand upon, and provide any needed clarification of the topics addressed on the call or on the corresponding read-ahead. This document is not a verbatim recitation of the call or read-ahead. If you have specific questions related to claims, please send them to the DES Mailbox (VAVBAWAS/CO/DES). A Compensation Service team member will contact you to gather the additional information needed to review and respond to your case. If a pattern is established, and we note several intake sites are having issues, a Compensation Service team member will discuss the topic on the following month's call.

TMS #4447946 has been created to provide training credit for the April 2018 IDES Teleconference. In order to receive the credit, you must sign into TMS and self-assign the course. The evaluation must be completed in order to receive credit for today's call.

Topics for Discussion

Exam Management System (EMS) in VBMS

Exam Management in VBMS was introduced in VBMS Release 14.1 (March 11th), and currently the only IDES exam provider supported by EMS is VES, which provides IDES examinations in OCONUS locations.

VBMS Contentions

MSCs are reminded to select the correct dropdown choices when completing the New Contention data fields (M21-1, III.iii.1.F.2.c). Entering the contention accurately allows VA to collect information on the nature of disabilities involved in Veterans' claims. The DRAS has seen a number of cases where the MSC is selecting the first choice in some of the dropdowns, when it has nothing to do with the contention; Ex: Contention is Lower Back Pain and the Classification selected was "Adhesions – Digestive" (which is the first selection in the dropdown).



This is a data integrity issue, the incorrect choices are called non-critical errors by QRT and have to be corrected by the DRAS'.

Veterans Tracking Application (VTA) Reminders

Cases in VTA that Require New MSC Assigned

MSC Coaches are responsible for reassigning cases in VTA when the MSC assigned no longer supports IDES. The MSC coach should run the MSC Case Load Report which is located under IDES Reports, Operation Reports. This report shows the Assigned MSC and the Number of Active Cases. If the report shows Active Cases for an Assigned MSC that no longer supports IDES, those cases need to be re-assigned. To find the cases that require reassignment, run a User Defined Report using the following selections:

Click Continue once all selections are made.

On next page (under filter options) select:

- Disenrollment Status: Enrollment Approved
- MSC Assigned: Select the MSC that is no longer supporting IDES

Click Run Report. The report generated will show the cases that need to be re-assigned.
