- 6. Once in the Fiduciary Fund Usage Review record there are three sections to review:
 - **General Information** Fiduciary Fund Usage Review Name, Name of Fiduciary, VA Fiduciary Hub, Starting Date, Ending Date, Signature of the Fiduciary, Submitted Date, First Name of Veteran, Middle Name of Veteran, Last Name of Veteran, VA File Number, First Name of Beneficiary, and Last Name of Beneficiary.
 - **Review Information-** Reviewer, Surety Bond, Court Documents, Additional Bonds Purchase, Saving Bonds Cashed, Status, Disposition, Reason for Incomplete, Revisions Requested, and Additional Remarks.
 - **Reporting Fields** Returned Date, Revisions Submitted Date, Fiduciary Return Count, Fiduciary Contact, Created By, Completed Date, Incomplete Date, Number of Days to Complete, Number of Days to Incomplete, Owner(List view name), and Last Modified.

The **Review information** section is the only section that can be edited by and LIE. As a reviewer the LIE can edit/update the surety bond, court documents, additional bonds purchased, and savings bonds cashed fields.
