 To begin the process, under the EP overview tab, a user will need to access the table titled "Generate Report of Field Exam". Within this table <u>click</u> the button "Add VA-Form 21-3537b".

Note: In open status, a 21-3537b can be previewed, edited or discarded. Discards are logged in the Audit History and not retrievable by users.
