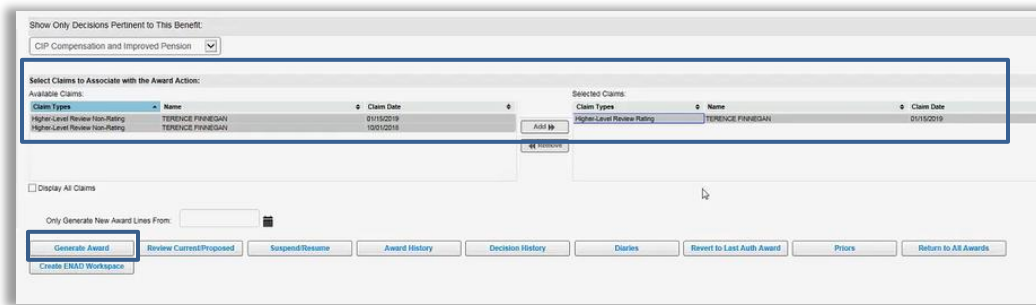
AMA Non-Rating Dispositions

OVERVIEW

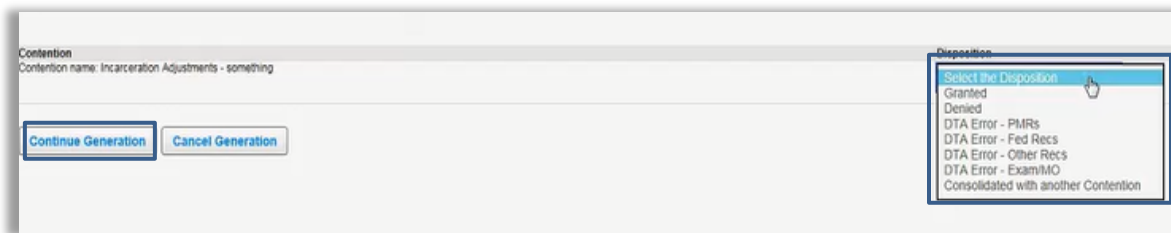
Under the Appeals Modernization Act (AMA) a claimant who is dissatisfied with a VA decision may file a request for **Higher-Level Review**, a de novo review by a reviewer with difference of opinion authority (see 38 CFR § 3.2601) or file a **Supplemental Claim**, a request for review of new and relevant evidence not previously considered by VA (see 38 CFR § 3.2501).

Decisionmakers (DRO, RVSR, or VSR) will be required to provide issue-based dispositions when working any AMA claims. Follow the instructions below to document **non-rating decision dispositions** in VBMS-Awards.

Step 1: From the Record Decisions Screen Add the *Claim Type* and select *Generate Award*



Step 2: The *Contention* screen populates, requiring users to select a *Disposition* before continuing with *Award Generation*. The *Dispositions* will be recorded upon *Authorization* of the pending end product (EP).



Note: The system will automatically establish an *o40 EP* if any “DTA Error” option is selected

Step 3: Confirm the claimant's *Payment Address*
