### Footnotes:

1. Does not apply to compensation cases if the Veteran has paraplegia involving paralysis of both lower extremities together with loss of anal & bladder sphincter control or Hansen's Disease, unless the Veteran is in receipt of SMC at the R1 or R2 level.
2. Does not apply to pension cases if the Veteran has blindness (visual acuity of 5/200 or less) or concentric contraction of visual field to 5 degrees or less, paraplegia involving paralysis of both lower extremities together with loss of anal & bladder sphincter control, or Hansen's Disease.
3. Does not apply if hospitalized for Hansen's Disease

### Definitions:

**Notes:** Due Process requires predetermination before taking away benefit. Due process does not require benefits be increased above evidence of record while development pending (i.e. discharged prior to award of A/A)

1. Private Pay - Pay A/A only through month of DSCHG, Develop for A/A on factual basis.
2. Vet DSCHG from NH at VA EXP Pay **HB** through end of month of DSCHG (subj to further reduction under 3.551)
